The purpose of this letter is to communicate the North Area Transportation Alliance's (NATA) support for the design and construction of the missing ramp on the northwest quadrant of the intersection of Peña Boulevard and Tower Road. NATA respectfully requests that the City of Denver fulfill its commitment to Commerce City by way of an expedited process to get the ramp built.
