RE: I-70 East Environmental Impact Statement (EIS) Preferred Alignment

Dear Mr. Akhavan:

The North Area Transportation Alliance (NATA) is an association of eleven local governments, the Metro North Chamber of Commerce, Adams County Economic Development Corporation, and businesses in the north east quadrant of the metro Denver area. NATA's partnership of public and private entities work to identify, develop, advocate and lobby for transportation solutions that will enhance mobility, drive economic development and reduce traffic congestion in the north metro area.

At its August 23, 2012 meeting, NATA was provided an update on the progress of the I-70 East EIS process. The Board identified several issues related to the EIS that they asked be passed on to the appropriate officials.

It is our understanding that an alternative realignment option has been proposed that would re-route I-70 using I-76 and I-270. Our concern with this realignment option is that it primarily impacts the north metro area and simply shifts the problem to the north, compounding significant congestion issues that have yet to be addressed. NATA does not support this option and requests it be removed from consideration.

NATA also was advised that CDOT recently proposed an option for the Swansea and Elyria communities which would remove the viaduct and reconstruct I-70 below ground. A portion of I-70 would be partially covered to provide additional open space and community uses. We understand this option has the support of these communities and we want to express our support of this option as well. It appears to be an innovative, workable solution for all involved.

We want to congratulate CDOT on developing a workable solution that not only improves I-70 on the existing alignment, but also presents an



alternative the communities can support. We look forward to the State reaching a Record of Decision on the I-70 East Final EIS in the near future.
